"The English Reports (full reprint) was issued in 178 volumes and is in general a straight reprint in which the original footnotes are given. Notes in square brackets have been inserted, as required, giving reference to Mews' Digest of English Case Law, while in some instances editorial notes in square brackets have been added.

Where pages of the original have been omitted this is usually stated and editorial notes indicate those decisions affected by subsequent legislation. The reprint edition contains over 100,000 cases, representative of 265 separate series of Reports, arranged by Courts. The whole set includes a two-volume index of cases and citations are recorded as they appear in the original reports. A table listing the nominate reports is also included in the series."
