### RESTATEMENTS OF THE LAW\* - NOW INCLUDES CURRENT RESTATEMENTS!

Restatements are essentially codifications of common law judge-made doctrines that develop gradually over time because of the principle of stare decisis. Although Restatements are not binding authority in and of themselves, they are highly persuasive because they are formulated over several years with extensive input from law professors, practicing attorneys, and judges. The Restatements of the Law is one of the most respected and well-used sources of secondary authority, covering nearly every area of common law. We have reordered this subcollection to be listed by category. Each category includes a more information link along with a description of the agency.

### PRINCIPLES OF THE LAW - NOW INCLUDES CURRENT PRINCIPLES OF LAW!

Just as the ALI's Restatements of the Law contain clear formulations of common law and its statutory elements or variations, reflect the law as it presently stands or might plausibly be stated by a court, the ALI's Principles of the Law analyze legal areas thought to be in need of reform. Principles aim to express the law as it should be. Like Restatements, Principles publications use the familiar black-letter statements of recommended legal rules, supports by Comments, Illustrations, and Reporter's Notes.

### UNIFORM COMMERCIAL CODE

The UCC is a comprehensive code addressing most aspects of commercial law, and is generally viewed as one of the most important developments in American law; it has been enacted (with some local variations) in 49 states and in the District of Columbia and the Virgin Islands, as well as partially in Louisiana. HeinOnline includes UCC Drafts from 1944 through current, including the 1962 Official Text with Comments.

### Case Law Linking Available: Links to Current Case Law

Case Law Linking is found and accessible throughout HeinOnline's American Law Institute Library. Case Law citations will be highlighted in blue and will link to the full text of the case powered by Fastcase.

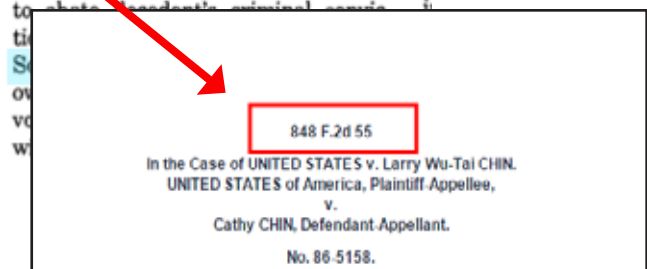

#### Case Law Coverage:

The federal case coverage includes the judicial opinions of the Supreme Court (1754-present), Federal Circuits (1924-present), Board of Tax Appeals (vols. 1-47), Tax Court Memorandum Decisions (vols. 1-59), U.S. Customs Court (vols. 1-70), Board of Immigration Appeals (1996-present), Federal District Courts (1924-present), and Federal Bankruptcy Courts (1 B.R. 1-present). The state case law covers all fifty states, with nearly half of the states dating back to the 1800s. Coverage for the remaining states dates back to approximately 1950.

## **"STATEMENT OF ESSENTIAL HUMAN RIGHTS" ARCHIVE**

A pioneering ALI project of the mid 1940's, "Statement of Essential Human Rights" is the Institute's contribution to post-war problems. For years it has been stored in the dark archives, never before available in digital format!

The ALI's effort to create a "Statement of Essential Human Rights" was a consequence of the tumultuous times faced by all during World War II. The Committee of Advisors tasked with creating and editing a draft of the Statement were unable to agree upon which human rights were indeed necessary and essential. Therefore, the Institute's involvement with the Statement of Essential Human Rights ceased and it was never released to the Institute's membership.

## **MODEL PENAL CODE**

The purpose of the Model Penal Code was to stimulate and assist legislatures in making a major effort to appraise the content of the penal law by a contemporary reasoned judgment the prohibitions it lays down, the excuses it admits, the sanctions it employs, and the range of the authority that it distributes and confers. Since its promulgation, the Code has played an important part in the widespread revision and codification of the substantive criminal law of the United States. HeinOnline includes the original Proposal to Prepare a Model Penal Code, Discussion, Council, Preliminary, and Tentative Drafts, as well as other Miscellaneous Documents related to the Code starting with 1951.

## **ALI-CLE PERIODICALS**

ALI-ABA has been a leader in continuing professional education in the United States for nearly 60 years. In 1947, the American Bar Association asked the American Law Institute to develop the first national program of post-admission legal education, which eventually led to the creation of ALI-CLE.

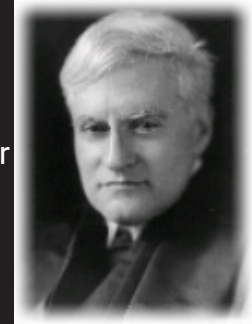
