**-About the AALS-**

The Association of American Law Schools is a resource for the improvement of the quality of legal education. It aims to network law school faculty, professional staff and deans to valuable legal information and resources. It is a non-profit association, founded in 1900, that now boasts over 168 member law schools.

**-AALS Directory of Law Teachers-**

The *Directory*, begun in 1922, is the most widely used “desk book” of deans and law teachers. It lists, by school, the full-time faculty and professional staff of all member and fee-paid law schools, contains biographical sketches of over 10,000 full-time teachers and law librarians, and lists full-time teachers by subject taught. There are also separate listings of minority group law teachers and gay and lesbian law teachers and of law school professional staff such as directors of admissions, development, placement, or alumni relations.

### **-Journal of Legal Education-**

The *Journal of Legal Education* is a quarterly publication of the Association of American Law Schools and is in its sixth decade of publication. The primary purpose of the Journal is to foster a rich interchange of ideas and information about legal education and related matters, including but not limited to the legal profession, legal theory, and legal scholarship. With a readership of more than 6,000 law teachers and about 600 subscribers, the Journal offers an unusually effective medium for communication to the law school world.

The Proceedings of the Association's Annual Meeting contains reports of committees and sections, text of addresses at the Association luncheon, and transcripts of the meetings of the AALS House of Representatives. It also contains the reports of special committees.
