DATABASES INCLUDED IN THE PACKAGE

Acts of the Parliament of the Canada (Annual Statutes)

Access all historical and current Acts of the Parliaments of Canada in an online, fully searchable format. To acquire the entire back file of the Acts of the Parliament for Canada on microfiche would cost more than \$12,000! This database provides an affordable solution for access to the full historical run of the Acts of the Parliament

Canada Supreme Court Reports

HeinOnline's Canada Supreme Court Reports contains the official, bilingual series published under authority of the Supreme Court Act. This database includes more than 10,000 cases which include background information, statutes and regulations, authors cited, analysis and the decisions.

Civil Rights and Social Justice

This database brings together a diverse offering of publications covering civil rights in the United States as their legal protections and definitions are expanded to cover more and more Americans.

Code of Federal Regulations (CFR)

The CFR is the codification of the general and permanent rules and regulations (sometimes called administrative law) published in the Federal Register by the executive departments and agencies of the federal government of the United States.

CourtListener (U.S. State & Federal Case Law)

Explore a vast collection of U.S. state & federal case law through HeinOnline's integration with CourtListener. Case law may be accessed seamlessly via citation lookup or inline hyperlinking within documents that cite the case. Coverage includes 99% of all precedential legal case law published in the United States.

COVID-19: Pandemics Past and Present

This database contains publications on the various ways COVID-19 has impacted every aspect of life, from testing issues in the medical field to unemployment and economic impact. This database, much like our understanding of COVID-19, will continue to evolve as new content is published and integrated with regular updates. Importantly, this collection also features subcollections dedicated to Past Pandemics, and Vaccinations.

Criminal Justice & Criminology

This collection offers an historical overview of how criminal justice has changed in American and English law and the effect criminology has had in facilitating those changes. It collects government documents as well as rare or hard to find pamphlets, memoirs, and books written by ordinary law enforcement officers and not-so-famous criminals.

Early American Case Law

Contains the entire Federal Cases 30 book series (1894-1897) which contains more than 20,000 cases. Also included is the Trinity Series, which includes American Decisions, American Reports, and American State Reports.

English Reports

HeinOnline's English Reports database delivers exact page images of the original bound reprint edition of *The English Reports*, along with the *Statutes of the Realm* (1235-1713), and pre-1865 law reports for England and Wales.

Federal Register

The Federal Register is the official journal of the federal government of the United States and contains government agency rules, proposed rules, and public notices. HeinOnline's coverage dates back to inception in 1936.

Foreign Relations of the United States (FRUS)

The Foreign Relations of the United States series presents the official documentary historical record of major U.S. foreign policy decisions and significant diplomatic activity. Hundreds of books are included, beginning with Abraham Lincoln's administration in 1861 and continuing through 1988.

Gun Regulation and Legislation in America

This database brings together essential periodicals, compiled legislative histories, CRS reports, Congressional hearings, United States Supreme Court briefs, monographs, and other related materials on the difficult and controversial topic of regulating firearms in the United States.

Law Academy Project

Discover the history of legal education in America through the works of the Law Academy, one of the earliest educational institutions in the United States for law-related education, established in 1821 in Philadelphia, PA. This database gathers the Academy's pamphlets and pairs them with biographical highlights of the author and a summary of its contents.

Law Journal Library

Contains more than 3,100 law and law-related periodicals. Subjects covered include criminal justice, political science, technology, human rights, and more. Coverage for all journals is from inception. About 90% of journals are available through the current issue or volume. Search by article title, author, subject, state or country published, or full text, and narrow by date.

Law Library of Congress Reports

More than 3,500 reports from the Law Library of Congress on foreign, comparative, and international law—all in one easy-to-navigate collection.

Legal Classics

Includes nearly 20,000 titles from some of the greatest legal minds in history, including Joseph Story, Jeremy Bentham, William Blackstone, William Holdsworth, Henry Maine, Federick William Maitland, Frederick Pollock, Benjamin N. Cardozo, and many more! In addition to classic treatises, this database also contains rare items that are found in only a handful of libraries around the world.

Legal Dictionaries

This impressive database of legal dictionaries is composed of more than 300 titles from various countries, on multiple topics. Key titles include the Compendius Dictionary of the English Language, several Concise Law Dictionaries, and more.

LGBTQ+ Rights

A collection of materials relating to the gay rights movement in America, including an interactive timeline, as well as subject-coded court cases, scholarly articles, books, pamphlets, reports, and more.

Military and Government

Provincial Statutes of Canada

Historical and revised content only is available for Newfoundland and Labrador, Prince Edward Island, Quebec, and Saskatchewan.

Revised Statutes of Canada

Slavery in America and the World: History, Culture & Law


