### 3. Bremer-Kovacs Collections:

#### Historic Documents Related to the Administrative Procedure Act of 1946

The *Bremer-Kovacs Collection: Historic Documents Related to the Administrative Procedure Act of 1946* is a comprehensive database designed to make the APA's history more accessible and understandable. The Collection begins in 1929 with the APA's first predecessors: bills to regulate administrative procedure that were introduced in Congress but never enacted. The database's coverage expands in 1933, tracking heightened interest in administrative reform following President Roosevelt's first inauguration and spurred on by the New Deal expansion of the federal administrative apparatus. The database includes a comprehensive legislative history of the Walter-Logan Bill of 1940, which Congress approved but President Roosevelt vetoed, as well as later bills that culminated in the Administrative Procedure Act of 1946 (APA). Compiled by Kathryn E. Kovacs, Emily S. Bremer, and Charlotte D. Schneider.

The database is rounded out with various tools to help researchers navigate the database, understand the documents in their rich historical context, and quickly identify the material most relevant to the user's precise interests. A Timeline charting the Act's passage is included within the database; access the full, comprehensive timeline prepared by Research Editor Charlotte Schneider here. Additionally, the Editors have written an essay that provides a concise narrative of the long road to the APA's adoption, putting the database's core documents in their proper historical context along the way.

## 7. Federal Register Library and 8. Code of Federal Regulations

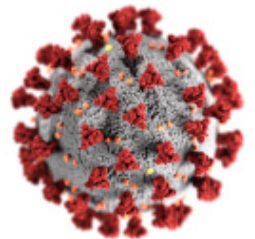
### Comprehensive coverage from inception

The Federal Register is updated daily in HeinOnline, which means you can always access material from the previous business day. In this library, you are able to quickly locate a Federal Register Document by citation or by date. Or, you can search across the full text of the Federal Register and narrow your search to a specific year or range of years.

Also included is the Code of Federal Regulations with coverage from inception (1938) to current. In the CFR library, you can locate a CFR title, part, or section using our Title/Part/Section Quick Locator Tool, or quickly search for a section using the CFR Citation Locator tool. Additional documents include the United States Government Manual from inception (1935) and the Daily and Weekly Compilation of Presidential Documents.

## 11. Executive Privilege

Executive privilege is the right of the president of the United States to keep certain information confidential from subpoenas and other oversight measures by the legislative and judicial branches of government.

The Foreign Relations of the United States series began in 1861 during the Lincoln administration and is composed of more than 3,275 volumes. It presents the official historical record of major U.S. foreign policy decisions and significant diplomatic activity. The volumes contain documents from various presidential libraries, the Departments of State and Defense, the National Security Council, the CIA, and other foreign affairs agencies, as well as the private papers of individuals involved in formulating U.S. foreign policy.

Also included in the library are other works related to U.S. foreign relations and foreign policy.

## 13. GAO Reports and Comptroller General Decisions

HeinOnline's GAO Reports and Comptroller General Decisions database contains reports on audits, surveys, investigations, and evaluations of federal programs conducted by the United States Government Accountability Office (GAO). All published reports, testimonies, correspondence, and special publications are included (documents that are restricted or classified are not). GAO Comptroller General Decisions contain decisions and opinions issued by the Comptroller General in areas of federal law such as appropriations, bid protests, and federal agency rulemaking.

The Government Publishing Office (GPO) has a partnership agreement with the GAO to provide permanent public access to these documents on the GAO website, but HeinOnline's metadata indexing, plus its fully searchable, user-friendly interface, make it simple to browse and search this content.

## 14. Gun Regulation and Legislation in America

The United States Code (U.S.C.) is a compilation and codification by subject matter of the general and permanent federal laws of the United States based on what is printed in the Statutes at Large. HeinOnline's coverage is from inception (1925-1926) to current.

This means that beyond the specific bill that becomes law, they include previous related bills and congressional reports and hearings related thereto. In contrast, I find that your competition seems to provide material that relates only to the final bill that becomes law. One cannot overstate the importance of this distinction for complete and thorough analysis of Congressional policy."*

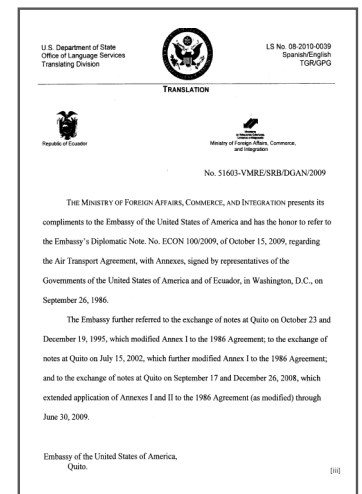
