


# U.S. Treaties & Agreements Library

A comprehensive collection of all United States treaties.

This valuable database includes all U.S. treaties, whether currently in-force, expired, or not-yet officially published. With **nearly 1,200 titles** and **1.2 million pages**, it includes prominent collections such as the United States Treaties and Other International Agreements set (commonly referred to as the “Blue Set”), as well as famous sets from Bevans, Miller, Malloy, and others.

In addition, this database includes nearly 300 hearings and nearly 900 books and texts relating to U.S. treaties as well as numerous treaty guides, indexes, and other treaty publications. For easy browsing, the U.S. Treaties & Agreements Library contains a unique U.S. Treaty Index search tool.
